

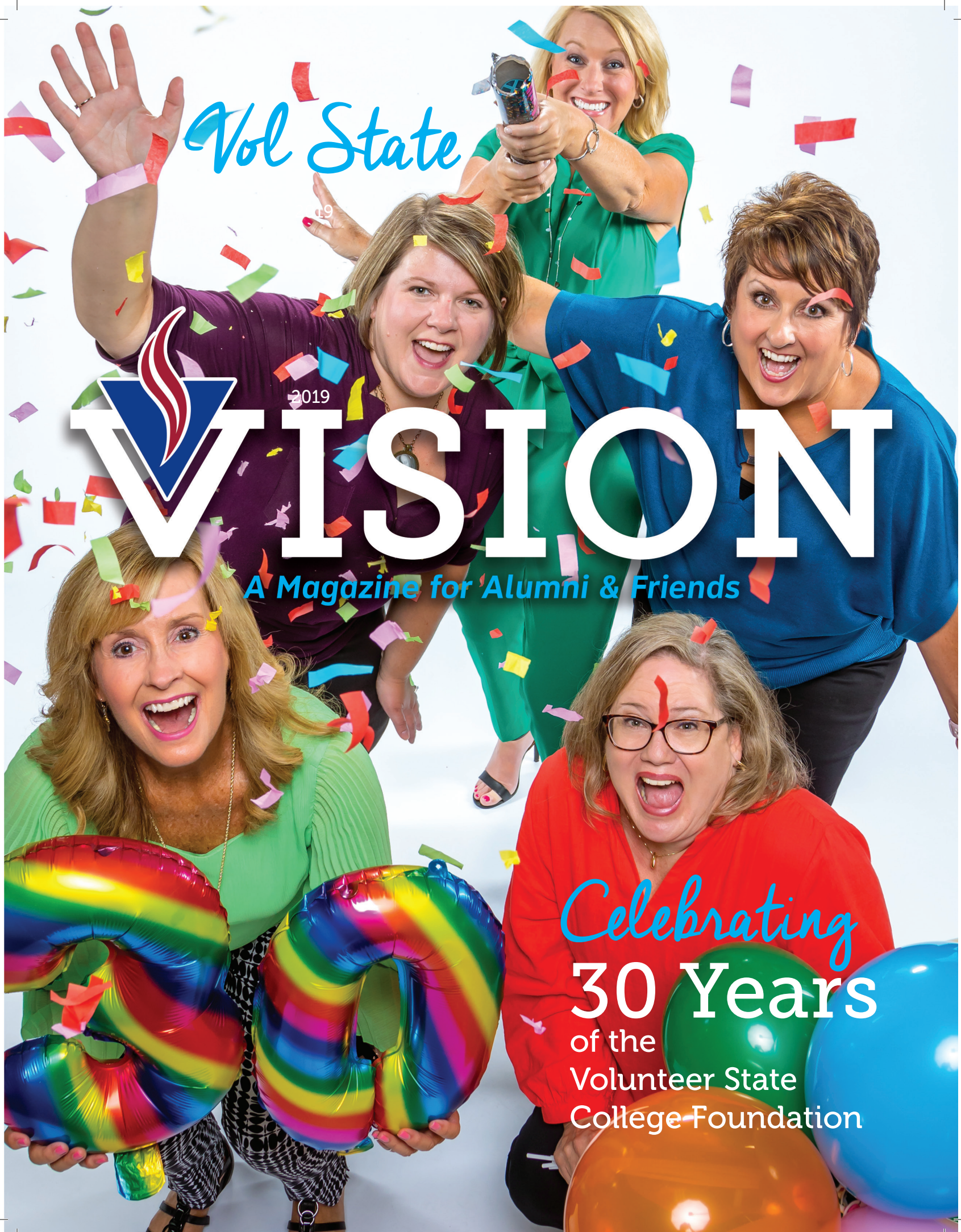



Three Decades Ago

Dr. Jerry Faulkner

Thirty years ago sounds like a long time, but in the eye of the memory, it was just a blink. What were you doing 30 years ago? Some were not even born. Some were too young to remember.

Thirty years ago *Road House*, *Dead Poets Society*, and *Bill and Ted's Excellent Adventure* premiered at the box office. On the small screen you may have watched Emmy award winning *Cheers* or tuned in for the first season of *Seinfeld* or the first episode of the *Simpsons*. The ear-worm, *Don't Worry, Be Happy* may have played in your mind as well as on your radio.

George H.W. Bush was in his first term, and we were still reading his lips. We watched the evening news as the Berlin Wall came down and the Brandenburg Gate opened. We were glued to our sets as a lone man, later to be known as "tank man," obstructed a line of communist army tanks in Tiananmen Square.

It was the time of the Exxon Valdez oil spill. Lexus and Infiniti cars made their appearance, and the U.S. Army first used Humvees in their invasion of Panama.

Thirty years ago the first HDTV broadcast occurred in Japan. The first commercial internet service provider offered access to "The World," and the first written proposal for the World Wide Web appeared. You may have purchased for only \$2,995 the Motorola Micro TAC Personal Cellular Telephone – the first flip phone and at that time the smallest and lightest. Nintendo released the Game Boy, and Robert Tappan Morris was the first person indicted for releasing a computer virus.

Back at Vol State, 194 students received certificates and degrees at the May ceremony where Senator Robert Rochelle spoke. Paying \$390 in tuition and fees, 3,670 students started the Fall 1989 semester. Females only made up 41.7% of that class and 38.6% of students were married. The need for scholarships was becoming more apparent, and the Foundation was established.

Much has changed at Vol State since 1989. We now have four campuses across our service area and plan in the near future to add a fifth in Wilson County. Enrollment has topped 9,000 and 60.7% are female. Full-Time Equivalency (FTE) is above 6,000 meaning we are delivering more

education to more people than ever in the history of the college. There are more than 90 programs of study available to our students, and this year we will award more than 1,500 degrees and certificates. The cost of one semester, full-time tuition and fees is \$2,166.

But what hasn't changed is that students still have needs for help with the cost of college. And this year we celebrate 30 years that the Volunteer State College Foundation has been helping students.

Celebrating 30 Years of the Volunteer State College Foundation

The Volunteer State College Foundation was chartered in 1989 when community leaders Robert Jennings, Peter Prater, Randy Wood, and Hal R. Ramer filed for incorporation as a nonprofit 501(c)3. The Board of Trustees consisted of 23 outstanding men and women who were committed to the access to quality education. Over \$31,000 was raised and \$10,000 was distributed in scholarships the first year.

Our mission statement is, "To raise and administer funds to support the educational objectives of Volunteer State Community College and to solicit the active involvement of all communities within our service area." Over the years, our mission has not changed.

Today, the Foundation awards over 240 scholarships annually. In these last 30 years over \$16,500,000 has been raised and over 5,800 scholarships awarded. The investments have supported scholarships, emergency funds, construction of new buildings, renovation of old buildings, program startups, Tennessee Small Business Development Center and many other initiatives of the college.

I am blessed to be an alumnus of Volunteer State Community College. I was a non-traditional student and came to college at age 24. I did not have stellar grades in high school and simply didn't know if I could handle college. I enrolled with fear and trembling but with every class and every semester, I gained confidence and realized that in fact, I could handle college! After transferring to a four-year university, I graduated with honors. My Vol State experience gave me the confidence to complete my dream. I picked up more than an education at Volunteer State Community College when I met my husband in tennis class!

In her thank you to the Volunteer State College Foundation, one mother of a scholarship recipient remarked how grateful she was for the "life changing scholarships" that are awarded. She went on to say that "their whole family had been touched not just the recipient." The Foundation changes lives. I am completely honored to serve as the Vice President for Resource Development and Executive Director of the Foundation. I would like to thank you for 30 years of changing lives and completing dreams!

... A Family TRADITION

For the McKee sisters of Gallatin, Volunteer State Community College is a family tradition. All three of them attended and worked at Vol State, and one is still here, helping students navigate the college experience and lay good foundations for their future:

- **Marylou McKee Piper** started in January 1983 and graduated with an Associate's Degree in Business.
- **Dr. Anne-Marie McKee** attended in the summer of 1984. She took English courses so she'd be better prepared for majoring in journalism at the University of Tennessee-Knoxville, where she received her Bachelor of Science degree in 1988. She has been at Vol State for 26 years and has recently begun a new role as Site Director for the Vol State at Highland Crest campus.
- **Elizabeth McKee Bentle** attended in the summer of 1987 and obtained an Associate's Degree in Early Education.

When the sisters were thinking about college, their parents wanted them to pursue a four-year degree. Marylou, who was the oldest, decided to go to another school at first, but she was miserable and hated it.

Luckily, she was able to persuade her parents to let her come home and attend Vol State. This paved the way for her sisters to attend when their times came.

"I just loved it here," Marylou said. "The class sizes weren't too big. There was a sense of comfort."

Elizabeth said, "I chose Vol State because it was home, and I was not going to leave home."

Vol State not only gave them a sense of comfort and family, it also prepared them for their future careers.

Marylou stated. "We were pretty well suited for what we thought we wanted to do, and stayed true to that."

Anne-Marie said she succeeded "because of an excellent professor, the late Ginny Thigpen, who gave me strong basic skills for my studies in journalism."

"That level of concern makes a big difference in a student's academic experience," Elizabeth says. "Once you're here, people know you, and once you declare your major, you are in classes with the same people. Professors know you. There is a sense of welcoming and comfort."

For example, Marylou and Elizabeth both transitioned from work-study students to part-time staff while still enrolled. Marylou indicated that the reputation students build through their academic relationships can be a big selling point for being hired.

"I loved working here," Marylou said. "I worked in the business office. I commuted to Middle Tennessee State University (MTSU) from Gallatin so I could work at Vol State."

"The experience allowed me to meet new people," Elizabeth added.

Anne-Marie returned to campus in 1994 as the assistant to the Vice President of the College, who was Charles Lee at the time. Since then, she has held several other positions including Evening Students Services Director, adjunct instructor in the business division, and her new role as Site Director for the Vol State at Highland Crest campus.

Just like many others who came through the doors of Vol State, these sisters were able to lay solid foundations for their futures. Their ongoing support and involvement in the college exemplifies that "Once a Pioneer, Always a Pioneer."

Alumni SCHOLARSHIPS

The Volunteer State Community College Alumni Scholarships are awarded by the Vol State Alumni Advisory Council and are funded **by** alumni dollars. These scholarships vary in covering book scholarships to full tuition for 1-academic year. To qualify for the scholarship, the recipient must be a relative of a VSCC alumni, have a minimum grade point average and complete an essay stating why the scholarship would be beneficial to them.

This year, the VSCC Alumni Advisory Council was able to award five deserving students a scholarship to assist with books or tuition. It is through the generosity of the Volunteer State Community College Alumni Association that we are able to complete the dreams of an education for these students.

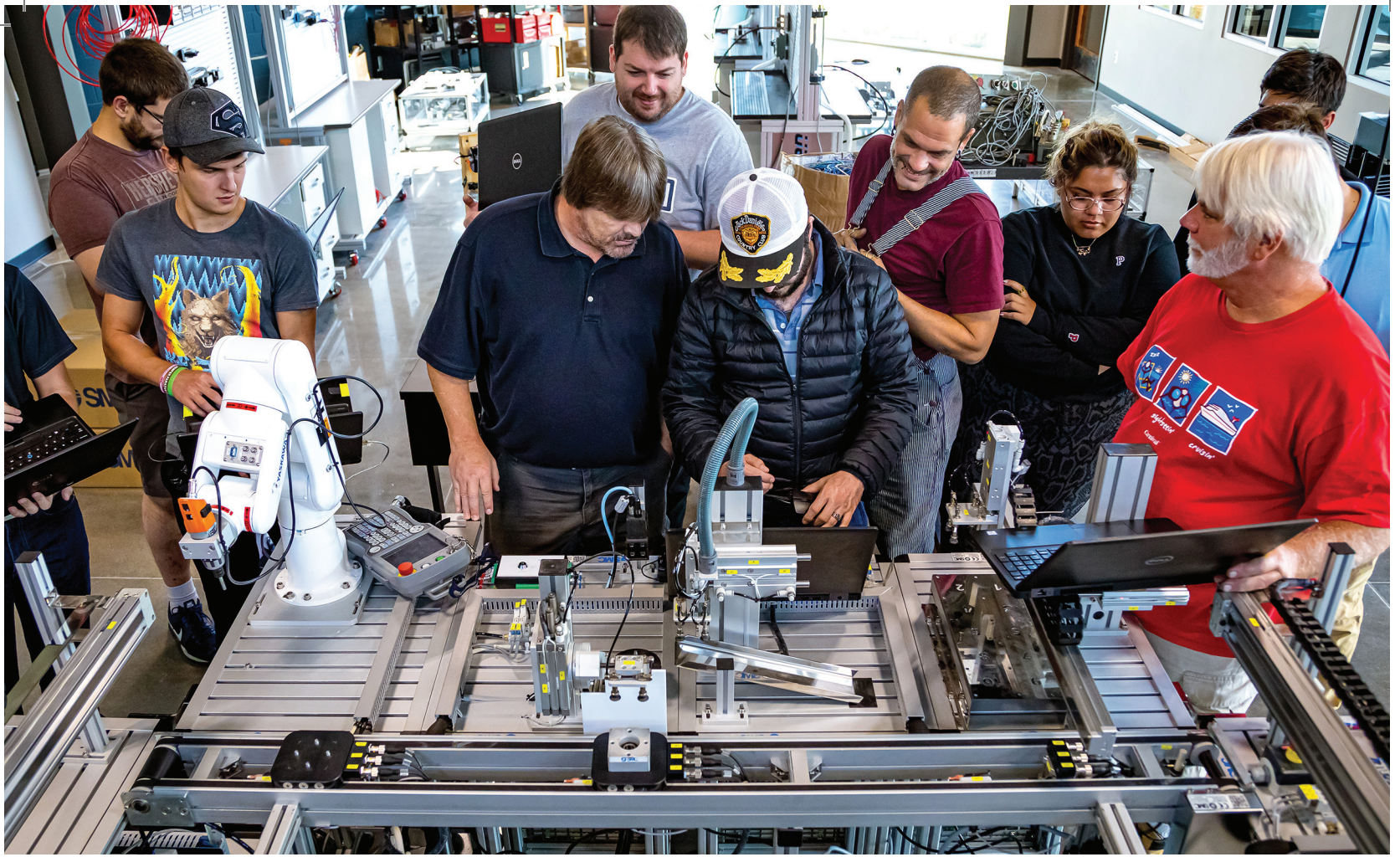
Are you a VSCC Alumnus? Please Update Your Info!

On the Wings of INNOVATION

Science education requires specialized equipment and labs. Teaching technology is constantly evolving and for those that are pursuing a science, technology engineering, or math (STEM) career, it is critical that they have exposure to state of the art equipment and facilities. Volunteer State Community College is celebrating the fall 2019 opening of a \$6.2 million renovation of the J. Howard Warf Building. Included in the renovation, an additional 6,000 square feet has been added that is home to a new Mechatronics lab.

Vol State offers a two-year Associates of Applied Science Degree in Mechatronics. The program prepares students to test for Siemens Certification, an internationally recognized Mechatronics industry designation. Classes are held at the Cookeville and Gallatin campuses. Mechatronics jobs have a national median salary of \$57,790 (Bureau of Labor Statistics).

Welcome Vol State's New Nursing Program

Today more than ever, the demand for nurses continues to rise. Vol State has begun a nursing program that will train nurses to be thought leaders in healthcare. For several years, Volunteer State Community College has offered pre-nursing programs. However, as demands on the healthcare industry continue to increase, it is clear that the field of nursing must continue to employ qualified individuals to fill the need. "It is the right time for Vol State to

launch a nursing program that serves our eleven county service area," says Vol State president, Jerry Faulkner. The new nursing program is offered at the Gallatin and Livingston campuses. "There is a critical and growing need for nurses in Sumner County and the surrounding area, including the Upper Cumberland," shares Dr. Faulkner.

"Nursing jobs, nationally are expected to increase by 15 percent, a much higher rate than most occupations. The

pay is also attractive with a median RN salary in Tennessee of \$67,490." The new Volunteer State Community College nursing program prepares students to apply to sit for the registered nurse (RN) exam and transfers to university programs. This allows students to seamlessly continue their studies for a Bachelor of Science in Nursing.

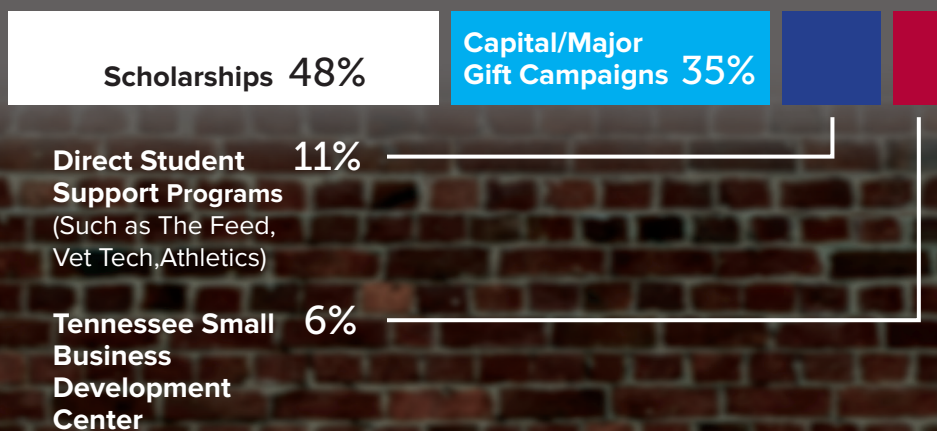

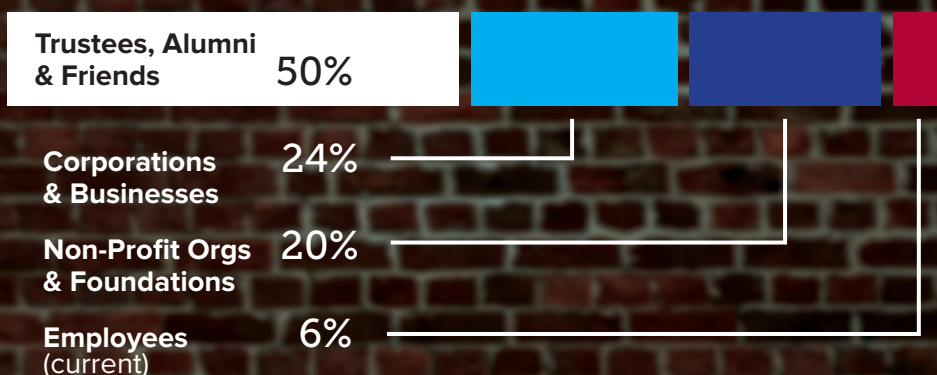

In Memoriam

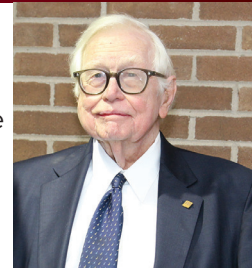
Chancellor Tom Gray
