

The Gallatin Vol State campus was founded in 1971 and is considered the "main" campus out of the four operated by the college. Vol State offers two-year degrees, certificates and paths to university transfer. Divisions include Business and Technology, Health Sciences, Math and Science, Social Science and Education, Nursing and Humanities. The campus has eighteen buildings that span over the 110-acre property in Gallatin.

This campus location offers the largest set of academic programs which include a wide variety of AAS and AS degrees in over 100 academic areas that include two-year degrees and one-year certificates in fields such as General Studies, Entertainment Media, Veterinary Technology, Sonography, Pre-Nursing, Dental Assistant, Biology, Elementary Education and many more. Many programs are included in the Tennessee Transfer Pathway program to ensure ease of credit transfer to any public, four-year institution in Tennessee.

Vol State serves as a vibrant part of this community. Our campus location also hosts our athletic teams, which include baseball, softball and men's and women's basketball. The Vol State sports teams are nicknamed the Pioneers and the Lady Pioneers.

Additional student activities at Vol State include a student newspaper, literary magazine, recording studios, a radio station, and a television studio. Students participate in numerous musical groups, theater performances and dozens of student organizations.

The college also offers a host of programs focused on training and certifications:

Celebrating Coach Lynn and Lady Pioneers 1,000 Wins

During the 2022 Lady Pioneers softball season, Coach Lynn celebrated a monumental win for his career and the Vol State softball program. On March 24th against Kishwaukee College, Coach Lynn reached a career win of 1000 games over his now 30 years of coaching. Following his career milestone record, on April 19th he and the Lady Pioneers reached 1000 wins for the Lady Pioneer Softball program. Coach Lynn has coached at Vol State for the past 29 years, leading his team to six state championships and a trip to the JUCO World Series in 2011. Lynn founded the softball program at Vol State in 1993 and has been a coach here for 29 years. The Lady Pioneers and Coach Lynn will jump into action on February 7th for the 2023 softball season.

First Year as the Vol State Pioneers Baseball Coach – Jim McGuire

Tennessee Baseball Coaches Association Hall of Fame Coach Jim McGuire joined Vol State Athletics as the head baseball coach in 2021. Prior to joining the Pioneers coaching staff, he was the head coach at Middle Tennessee State University from 2012 to 2018 and the associate head baseball coach and assistant baseball coach at MTSU since 1993. In addition to his college coaching, Coach McGuire was the Director of Baseball Operations at Hit after Hit Baseball Academy in Nashville. Coach McGuire led the 2022 Vol State Pioneers baseball program to 27-21 season in his first year as the VSCC coach. When asked about the upcoming season, Coach McGuire shared, "I am looking forward to the 2023 season. We have a good mix of new and returning players to build on what we started last year. Excited to see what this team can do this spring!" Opening day for 2023 is at Central Alabama CC in Alexander City, AL on February 4.


The Bishops were instrumental in raising funds for the Vol State Livingston new building campaign and contributed financially to the campaign along with funding their scholarship. The entrance to the Livingston Campus is named for Budd and Julia Bishop.

Budd and Julia felt so strongly about Volunteer State
Community College and the Livingston campus,
that they wanted others to invest in scholarships
for students to attend that campus. They started a
fundraising event called Vol E Ball, with the "E" standing
for "education." The first event was held in the spring
of 2011 and facilitated each year through 2015. This
popular event generated over \$207,000 in revenue
during a five-year period and touched more than 200
students in Overton County. Funds were also used to
purchase books for Dual Enrollment students as part of
the Vol State First initiative.



Since Julia's retirement, she has served the community in various capacities including the Volunteer State Community College President's Advisory Board, Member of the Downtown Livingston Revitalization Committee, and the Envision Committee.
